Annual Report: July 2023-June 2024 TRANSITION SITKA

Between July 2023 and June 2024 Transition Sitka has been successful in applying for our first large-ish grant under our 501 (c) (3) tax exempt non-profit status. Our fundraising efforts for the Jarvis Street Community Garden will continue in 2025. Other projects for this year included a second electrification expo, exploring electrical trades education in Southeast Alaska,

and an update of the 2014 assessment of Sitka's access to food.

All in this together

Our first big projects have given us opportunities to collaborate with the many non-profit organizations who are working on vulnerability, resilience and self-sufficiency in Sitka. Our project leads met with the municipality, Alaska's state university system, and a range off local community service organizations to complete important stages of this work! Many community members continued to show their interest in community gardening, and reducing the cost of living by making smarter decisions about managing our waste streams!

Electrification

The electrification working group continued to explore the needs and opportunities for electrification in Sitka, including the need for greater support in electrical trades training. The Electrification subgroup conducted interviews with heat pump installers and other tradespeople regarding their needs and perceptions about what they need for the clean energy transition. This information supported three meetings with stakeholders at University of Alaska Southeast, the last including union representatives from the International Brotherhood of Electrical Workers and Plumbers and Pipefitters. At our second Electrification Expo at Centennial Hall, we added expert presentations to stakeholder tabling and tried to stimulate interest among high school students in trades apprenticeships. We held a public meeting to solicit citizen concerns about energy planning, summarizing our findings for the Sitka Assembly. We continued to inform the Sitka School Board about funding options for electric school buses and their life cycle costs.

Food Security

The food security working group continued with the development of a community garden and, in partnership with the Sitka Local Food Network, launched a 10 year update to the Sitka Community Food Assessment. Callie Simmons, University of Alaska Anchorage Masters of Public Health student, took the lead, mentored by Lisa Sadleir-Hart and worked with a broad-based steering committee. The assessment included a food security survey with 387 valid responses, 26 interviews with key informants and food producers, six focus groups with 46 attendees. The assessment was supported by two local grants from the Sitka Rotary Club and the White E. The final assessment will be available Fall 2024 with community presentations to follow. President's Report - Joel Hanson

Transition Sitka was formed to begin the urgent work needed to make our community more resilient in the face of three great challenges: declines in the the amount and quality of fossil fuel resources, the social, environmental and economic consequences of these declines, and the need to accelerate the transition away from fossil fuels to restore the climatic conditions that have supported people in Sitka for thousands of years.

In setting a target of Earth Day (April 22) in 2030, our members have confirmed a conviction that addressing these challenges cannot be kicked down the road. We have met to work on the projects of beneficial electrification, food security, energy security, solid waste reduction, and alternatives to growth driven, cash-based economies.

As much as anyone, we feel the anxiety of change that we can't control. We have found comfort and purpose in working together on the changes that we can make to create a community that will be strong and thriving under very different circumstances. This is community work and we believe that we are in the right community to be very successful in achieving this goal.

Treasurer's Report - Leah Mason

Transition Sitka registered as a 501 (c) (3) non-profit organization in May 2023 which allows us to offer a tax-free status for funds that are donated to us. This is particularly important success in applying for large grants.

In financial year 2023-2024 we began to build on this foundational change to our financial situation. We were successful in applying for several smaller grants from local organizations and from a state-based foundation. These are shown in our balance sheet on page 4 of this report. As at June 30 2024 we have \$12,557 from foundations, and \$5352 from local charitable organizations such as Sitka Rotary (Community Food Assessment), the Sitka White E (Community Food Assessment).

We were also the beneficiaries of the funds raised by the Sitka Chapter of the Citizens Climate Lobby, and donations from members, as well as some members of the public.

Several firsts for the organization have been a successful crowd-funding activity for the Community Garden garnered 2410, and the use of a Certificate of Deposit for unrestricted funds (1500), which has already added \$16 in interest to our account.

The Jarvis Street Community Garden and Sitka Community Food Assessment projects will be ongoing during the next financial year.
